# Sharpshooters USA Club Membership Terms and Conditions

1. Sharpshooters USA Club ("Sharpshooters Club") is a private membership club which is wholly owned by Sharpshooters USA, LLC. Acceptance for membership in Sharpshooters Club does not confer on the holder any membership, rights, or ownership interest in Sharpshooters USA, LLC. Sharpshooters Club facilities are available for use by all Sharpshooters Club Members, Guests of Members, private citizen groups and by the general public. Sharpshooters' Memberships are available to provide preferred access, discounts for merchandise, services and facility use, and other benefits to Sharpshooters Club Members. Sharpshooters Club Membership is subject to the Membership Terms and Conditions stated herein. Membership will be granted, and may be revoked, at the sole discretion of Sharpshooters Club.

2. As part of the consideration for Membership, the Member hereby agrees to remain a Member and pay the Monthly Membership Dues for a period of not less than one (1) year from the date of this Agreement. Sharpshooters USA LLC is entitled to recover its costs, including reasonable attorneys' fees, incurred in collecting sums due to Sharpshooters USA, LLC under this or any other Membership provision or otherwise. A cancellation fee of \$100 dollars or the balance of the contract, whichever is less, will be assessed to the member if cancellation is required within the first twelve (12) months of this agreement.

3. All Memberships are subject to payment of a one-time non-refundable Initiation Fee and timely payment of Monthly Membership dues. The Initiation Fee and Monthly Membership dues for each level of Membership vary based on the level of Membership purchased, special Sharpshooters Club promotions and Membership availability. Membership dues and benefits may be reviewed and adjusted by Sharpshooters USA, LLC at any time.

4. Members may select one of the following methods of payment for their Monthly Membership dues: Automatic monthly credit/debit payment from a VISA, MasterCard, American Express, or Discover Cards. A\$20 fee will be assessed for any automatic debit that is rejected for insufficient funds or any failed credit charge.

5. All Members, Guests, and other Sharpshooters Club facility users must follow all Sharpshooters Safety Standards and Range Rules, and must read, and agree to the terms of the Sharpshooters USA, LLC Waiver Of Liability, Release Of Claims, and Agreement To Hold Harmless, Defend, And Indemnify which is incorporated by reference into the Sharpshooters Club Terms and Conditions of Membership. All first-time Members, Guests, and other Sharpshooters facility users also must participate in the Sharpshooters Club range orientation and watch the Sharpshooters Club safety presentation before shooting at the range.

6. All Guests must be accompanied by a Member to be admitted to the firing line. Members are responsible for all actions taken by their Guests and will hold Sharpshooters harmless for property damage, accidents and injuries to or caused by Guests.

7. All Members and Guests are subject to the general policies and rules of operation and administration of Sharpshooters Club, all of which are intended to provide a safe, professional, friendly and family-oriented club.



8. Any Member or Guest of a Member may be suspended or expelled from the range and/or facility for violation of the Range Rules or for behavior deemed unsafe by Sharpshooters Club personnel. Decisions of Sharpshooters Club regarding suspension or expulsion are final.

9. Sharpshooters Club may terminate a Membership unilaterally if, in Sharpshooters' sole discretion, a Member's conduct presents a safety hazard to the Member or to any other user or Sharpshooters Club employee or to Sharpshooters Club facilities. In the event Sharpshooters Club terminates a Membership during the first year of Membership, the unused portion of the Member's Initiation Fee will be refunded on a pro-rated basis over the first 12 months of Membership for the unused months of the first year's membership. For purposes of this paragraph, a "month" shall include any part of a month. For example, if a Membership is unilaterally terminated by Sharpshooters Club anytime in the first month, the Member would receive a refund of 11/12 of the Initiation Fee. After 12 months of Membership, no portion of the Initiation Fee will be refunded in any manner. In no event will there be any refund of any Monthly Membership dues paid. Other than unilateral Membership termination by Sharpshooters Club during the first 12 months of Membership termination by Sharpshooters Club during the first 12 months of Membership termination by Sharpshooters Club during the first 12 months of Membership, the Initiation Fee will be refunded in any manner. In no event will there be any refund of any Monthly Membership dues paid. Other than unilateral Membership termination by Sharpshooters Club during the first 12 months of Membership, the Initiation Fee is non-refundable.

10. After the first year of Membership, Membership shall be considered "abandoned" and will be terminated for non-payment of the Monthly Membership dues for two consecutive months. Where Membership is abandoned, there is no refund of any portion of the Initiation Fee or Monthly Membership dues.

11. If a Member or a Member's Guest causes any damage to Sharpshooters Club property, whether accidental, negligent, willful or otherwise, the Member (and the Member's guest) will be removed from the range and/or facility, and suspended or terminated from Membership. The individual responsible for the damage may be civilly liable or criminally prosecuted. Sharpshooters reserve the right to charge the Member the costs for any such damage, regardless of whether the damage is caused by the Member or the Member's Guest. Should court action be required to collect the damages, the Member will also be liable for Sharpshooters'Club attorneys fees.

12. All Sharpshooters'club Members will be photographed for Sharpshooters records and identification, and all Members must present their Sharpshooters Club Identification cards whenever they use Sharpshooters Club facilities. All guests must present a photo ID before using Sharpshooters' Club facilities

13. Sharpshooters Club Membership may not be transferred or sold.
